#### APPLICATION FOR PERSONS WISHING TO REPRESENT STAKEHOLDERS IN THE BOARD OF DIRECTORS OF ISIOLO WATER AND SEWERAGE COMPANY LTD.

Isiolo Water and Sewerage Company (IWASCO) is a Water Service Provider fully owned by County Government of Isiolo that has been mandated to provide water and sewerage services in Isiolo Town and its environs.

Isiolo county public service board wishes to recruit competent and qualified residents of Isiolo County for the positions of members of the Board of Directors for the company in line with section 59 of the CGA 2012.

The company is managed by a Board of Directors whose primary function is to oversight the management function to ensure the attainment of the company's long term goals and objectives.

The Board of the Company has vacancies for representatives of the following stakeholders:

#### **ELIGIBILITY CRITERIA**

To be eligible, all applicants must:-

- i. Hold at least KCSE, higher levels of education will be an added advantage.
- ii. Experience in policy formulation, strategies and business plans in public/ private sector or NGO.
- iii. Demonstrate experience in business or any other profession for at least 5 years.
- iv. Demonstrate participation and involvement in local development initiatives.
- v. Demonstrate experience in change management agent.
- vi. Knowledge of Water Sector Reforms will be an added advantage.
- vii. Be a resident of Isiolo County and a consumer of IWASCO water.

- viii. Be above 35 years of age and below 70 years.
- ix. Obtain a recommendation letter from the nominating body
- x. Fulfill conditions of Chapter six of the Constitution of Kenya on Leadership and Integrity by submitting current copies of:-
  - 1. Clearance certificate from Ethics and Anti-Corruption Commission(EACC)
  - 2. Certificate of good conduct from the Criminal Investigation Department(CID)
  - 3. Clearance certificate from Higher Education Loans Board(HELB)
  - 4. Certificate of Compliance from Kenya Revenue Authority(KRA)

- 1. Suppliers or other trading associates of the company and
- 2. Persons in current professional or social relationships with the Directors/Staff of the company are not eligible.
