AN ACT of the County Assembly of Isiolo to authorize the issue of the County revenue Fund and their application towards the service for the year ending on the 30th June, 2024, and to appropriate those sums for public services and purposes

**ENACTED** by the County Assembly of Isiolo, as follows—

1. This Act may be cited as the Isiolo County Appropriation Act, 2023.

2. The County Treasury may issue the sum of Kenya Shillings Five Billion, Three Hundred and Thirty Three Million, Four Hundred and Eighty Nine Thousand, Eight Hundred and Eighty Six only from the County Revenue Fund and apply it towards the service for the year ending on the 30th June, 2024.

**3.** The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule

4. In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the Consolidated Fund under Article 206 (1) (b) of the Constitution.

5. The supply granted for the services of the year ending on the 30th June, 2024, in respect of Votes R3510000000, and D3510000000 in accordance with the Appropriation Act, 2023.
